Website Terms of Use

1. Definitions

You, your and yours refer to the cardholder who is accessing or attempting to access the Website.

We, us, our and Blackhawk Network refer to Blackhawk Network (Canada) Ltd. and its affiliates, the provider of the Website for Loblaw.

2. Acceptance

These Terms of Use set forth the terms and conditions under which you may use this website ("Website"). By accessing the Website or using the services offered through the Website ("Service") (including accessing information regarding your use of the prepaid card fulfilled by Blackhawk Network ("Card"), but not, for certainty, any use of the Card pursuant to the Loblaw Card Cardholder Agreement), you agree to be bound by the Terms of Use. IF YOU DO NOT AGREE TO THE TERMS OF USE (WITHOUT MODIFICATION), YOU ARE NOT AUTHORIZED TO ACCESS OR OTHERWISE USE THIS WEBSITE. THESE TERMS OF USE DO NOT APPLY TO THE USE OF THE CARD, WHICH WILL BE GOVERNED BY THE LOBLAW CARDHOLDER AGREEMENT.

3. Use of the Website

Blackhawk Network grants you a non-transferable and limited license to access and make use of the Website to utilize the Service. The license granted in this Paragraph 3 does not include any resale or commercial use of the Website or any information contained on the Website (the "Content"); any derivative use of this site or the Content; any downloading or copying of information or Content; or any use of data mining, robots, or similar data gathering and extraction tools.

You acknowledge and agree that, without the prior written consent of Blackhawk Network, you will not:

Blackhawk Network may, without prior notice or any liability to you for such action, (a) revise these Terms of Use, provided that if you are a resident of Québec we will provide you with notice at least thirty (30) days before the revision comes into effect, and you may refuse the revision and rescind your use of the Website and Service without cost, penalty or cancellation indemnity, by sending Blackhawk Network notice to that effect no later than 30 days after the amendment comes into force; (b) modify the Website and/or the Service; and (c) discontinue the Website and/or Service at any time. Blackhawk Network shall post any revision to these Terms of Use to the Website, and the revision shall be effective immediately on such posting. These Terms of Use shall be construed in accordance with and governed by the laws of the province of Ontario and with the federal laws of Canada applicable therein, without reference to their rules regarding conflicts of law. You hereby irrevocably consent to the exclusive jurisdiction of the provincial or federal courts in Ontario, Canada in all disputes arising out of or related to the use of the Website or Service. However, in respect of residents of Québec, any claim or action brought pursuant to these Terms of Use will be subject to the exclusive jurisdiction of the courts of Québec and these Terms of Use will be construed in accordance with and governed by the laws of the Province of Québec and the federal laws applicable therein.
